

About Disclosure Request by Postal Mail

[About your Delivery Address for the Disclosure Result (Credit Information Disclosure Report)]

As a rule, the disclosure result will be sent to the address stated on your Certificate of Residence (“Juminhyo”), Certificate of Seal Registration (“Inkan Toroku Shomeisho”) or Supplementary Family Register (“Koseki no Fuhyo”)

1. Credit Information Disclosure Request Form
